## **Frequently Asked Questions**

### **Why does the Nevada Gaming Control Board (Board) regulate lotteries and gaming activities conducted by charitable organizations?**

In 1991, the Nevada Legislature enacted laws which, among other things, required the Board to regulate charitable lotteries and gaming. In 2019, the laws and regulations were amended. The recent amendments can be found here ([AB 202](#)). In general, the amendments were largely aimed at allowing increased fundraising activities, and to streamline the approval process for charitable organizations. ### **If a charitable organization raises funds through offering lotteries and/or games such as Bingo, Poker or Blackjack, must that organization register with the Board?**

Yes, registration with the Board is required. There are two applications available on our website, Form ENF-116 if there will be under \$100,000 in prize distribution during a calendar year or Form ENF-115 for Professional Sports Organizations or if there will be over \$100,000 in prize distributions during a calendar year. ### **Are there application fees? If so, what are the fees?**

- \* NO Fee: If the annual prize distribution is less than \$100,000
- \* \$25 Fee Per Event: If the annual prize distribution is more than \$100,000

- \* If the organization is a professional sports organization, as defined by NRS 462.140, the fee is \$200 per event. Additional technology fee may apply.

### **Are online ticket sales allowed?**

<ul style="list-style-type: none"> <li>♣ A person under the age of 18 cannot purchase tickets for entry into or collecting winnings from any charitable lottery offering a cash prize.</li> <li>♣ A qualified organization must present proof of nonprofit certification from the Nevada Department of Taxation, Internal Revenue Service, or Nevada Secretary of State.</li> <li>♣ Qualified organizations may only sell charitable lottery tickets to persons who are physically located in Nevada at the time of purchase.</li> <li>♣ Charitable lottery controls detailing <u>online</u> ticket sale operations must be provided with the lottery application and approved by the Chair.</li> <li>♣ Qualified organizations approved by the Chair must submit, upon request, financial reports concerning their charitable lottery.</li> <li>♣ The following are not categorized as lotteries per Nevada State law: <ul style="list-style-type: none"> <li>♣ Free Drawings</li> <li>♣ Silent Auctions</li> <li>♣ Live Auctions</li> </ul> </li> </ul>	<ul style="list-style-type: none"> <li>♣ All participants must be at least <u>21 years</u> of age to participate in charitable gaming.</li> <li>♣ A qualified organization must present proof of nonprofit certification from the Nevada Department of Taxation, Internal Revenue Service, or Nevada Secretary of State.</li> <li>♣ Charitable events involving gambling games are restricted to bingo, poker and blackjack. The use of gaming devices (slot machines/roulette wheels) are not allowed.</li> <li>♣ Charitable gaming rules must be retained and available upon request. Website screenshots of event advertisements, registrations, payment methods, if applicable can be submitted to ensure compliance with the law if an organization desires.</li> <li>♣ All charitable gaming activities must be operated to facilitate a nonprofit mission in which the proceeds are distributed to a Nevada nonprofit organization. Gaming events, which are designed strictly for recreational or social purposes, must be <u>free</u> with an option of donated prizes if desired.</li> </ul>
