Concerning the 2020 State convention in the South....Jim Shirkey asked why in the South? It was moved by Jim Shirkey, second by Dee Boskie that Reno #597 will have the 2020 State convention. Motion passed. Meeting times for the convention committee were also discussed.

Ted Balash spoke about the updates on NEMPI. An accounting system balance sheet has been created, monthly and quarterly reports are being sent and policies and procedures are being established by the State Major Project committee. Recording of funds by all NEMPI trustees and by-laws changes

and sales tax have been improved. The trustees now meet on Go To Meeting statewide with computers. D&O insurance, completed audit and a second person on check reconciliation have also been done. Al Bye talked about further accounting changes on gains and stocks.

He talked about the State Directory and how it will be pocket size and smaller with less ads and less duplications. He also gave Secretary a copy of new committee chairmen and visitation schedule for 2019-2020.

PGER Grillo also spoke about the Advisory Council selecting the future NSEA Vice-Presidents. The criteria for future Vice-Presidents were discussed and we need people with the right qualifications to run for NSEA office. A Vice-President North and a Vice-President South would be selected and the Advisory Council would select President elect from those two. Ted Balash talked about changing the NSEA by-laws and the Advisory Council would address this at the April meeting. Moved by Bill Wiseman, second by William Bohnett that there be a North and South Vice-President created. This will be brought to the Saturday meeting tomorrow. Discussion followed about Nevada system vs the proposed new Vice-President change.
