Dignitaries and Members All;

It is my honor to give this report as Accident Prevention and Insurance Risk - Vice Chair - North.

Out of 16 lodges in Nevada, we received report from Lodges. This is not an improvement from the last reporting period. I was able to assist one lodge navigate to the repost page.

One Lodge reported (3) three incidents; two trip and fall and one On the Job injury.

Just as a reminder, the Grand Lodge requires that each local lodge has an Accident Prevention/Insurance Risk Manager within the Lodge. One of your Trustees should fill this position. Your manager is required to perform monthly Lodge Self-safety Inspections which are reviewed at the District Deputy's visit each year. Please make sure that any problems found during the monthly inspection are corrected as soon as possible to protect your lodge and precious members. Your manager is also responsible to make sure that incident reports are readily available, properly filled out and submitted when required.

To the Lodges who forgot to do your reports, the Accident Report is the easiest one you have to do. If you don't know how to enter it on the NSEA site, please call or email me and I will happy to help you.

To the reporting lodges, keep up the good work! To the rest of you, get your reports in!

This has been a very challenging and busy year recovering from the effects of the COVID-19 virus plaguing us. I filled in as the Auditor to the DDGER due to Sue Buffamonte's passing. Other than the normal lodge DDGER visits a great deal of time was spent assisting the lodges with implementing the new Financial Reporting System (FRS). The greatest amount of work was spent cleaning up the current lodge books and accounts.

For lodge year 2021-22 we still have a few lodges with issues being corrected with FRS system. These issues need to be cleaned up to accomplish positive results for this years FRS upload and taxes. It should be noted before the lodge taxes can be uploaded to Grand Lodge they must be submitted to the DDGER along with the lodge balance sheet used for preparation of the taxes. Those documents along with the FRS report will be reviewed for matching numbers. Only after all numbers matched are the taxes to be uploaded. A new upload will be required to FPS system to handle any adjustment your accountant may have recommended during the preparation of the lodge taxes. Failure to do this will cause your upload to be flagged "Pending".

It should be noted no extensions will be granted this year beyond 1 August. This includes any extensions the lodge may have received from the IRS. As a result of the errors found during the conversion to the FRS system I cannot stress more the importance of selecting qualified Accounting Firm to prepare your annual taxes.

We continue to express the importance of properly reporting Unrelated Business Income (UBI). It is extremely important for the lodges renting their facilities to separate the rental agreement from the food and beverage service agreement to help prevent the lodge being charged UBI taxes on the total of the rental. UBI is one of the first things the IRS looks for in an audit of your lodge. Another area of concern is not reporting and paying Use Tax on goods purchase outside the state without sales tax being charged and using the goods in the state. A prime example of this is materials purchased from Grand Lodge - all require use tax to be paid. As with the IRS the first thing the State Franchise Tax Board looks for is unpaid Use Tax. It almost guaranteed something will be found in both cases giving cause for further digging.

Proposed Revisions to the Bylaws of the Association.

I am sending copies of the proposals to amend the Bylaws of the Association. The Bylaw changes modify the duties as assigned to the Trustees for review of records and establishes the position of NSEA Photographer along with the duties and provides a monetary allowance for the NSEA Photographer.

BYLAWS Change #1

ARTICLE VII - DUTIES OF OFFICERS

(d) delete as written and revise as:

Act as the auditing agency for the Association by annually providing for audit services, and in such a manner and at such time(s) as the President may direct or said Trustees deem practical or necessary, said audits shall be performed on the records and holdings, if any, of each officer and committee of the Association in charge of funds or other assets, and said Trustees shall include an audit report with its annual report.

Ensure the finances of the Association are being conducted correctly by annually providing for a review of the Treasurer and at such time(s) as the President may direct or said Trustees deem practical or necessary, said review shall be performed by either an internal or external entity as chosen by the Trustees. The review will include the records and holdings, if any, of each officer and committee of the Association in charge of funds or other assets and said Trustees shall include a review report with its annual report.

Financial impact: To be determined if external review is required.

Arguments for passage: Allows the Trustees to determine if external review is needed and allows them to proceed.

Arguments against passage: None

This proposal was presented by Rick Stone for the Trustees in order to clarify their duties in regards to Reviews and Reports.

Proposal 2 & 3 was presented by Rick Stone for the Trustees in order to clarify the duties and position for an Association Photographer.

The photographer shall be allowed a payment not to exceed Two hundred and fifty dollars (\$250.00) per annum for reimbursement of expenses, payable annually, but shall not be allowed any additional moneys as and or necessary personal expenses incurred in the conduct of the affairs of the office.

Renumber Section 18 - Special Committees as Section 19 - Special Committees:

Argument for: The photographer position has been filled for years as a volunteer position only. This will make it an Official NSEA position and allow for reimbursement of expenses.

Argument against: None

Financial impact: It would increase the budget by \$250.

It is respectfully requested that these documents be reviewed by your Lodge membership, and or individually as appropriate, and that your Representatives and Delegates be prepared to vote on the proposed changes at the upcoming Annual Business Meeting scheduled for April 23, 2022, at Boulder City Lodge No. 1682.



I have only heard from the Reno Lodge about their selection for Citizen of the Year. Dawn Forbus was selected for her many years of work with Honor Flight. I only got this information from "The Call for April 2022" which is the Lodge newsletter.

For all the Lodges who awarded a Citizen of the Year great job. Now the next step is to get the news of the selection out to the public. This program is designed by Grand Lodge to help inform the public how Elks work with their Local Community. Nevada Elks and Guests,

This last year the United States had more than one hundred thousand overdose deaths this puts opioid death as the number one cause of death in the United States. With the new threat of counterfeit drugs flooding into the US that have a lethal dose of fentanyl in 4 out of ten pills, that number will be surpassed. Most likely everyone in this room will know someone who will die from an overdose this year. The Lodges must get more active in prevention education so that we can prevent the useless deaths!

For this report there were 30 events with 215 Elks and 31 Non-elks, totaling 1407 Elk hours and 1111 non-elk hours and 3747 Elk miles and 3894 non-elk miles. 10,105 pieces of literature distributed to 36,384 participants. The Trailers were used 9 times along with 10 Elroy appearances. There were 27 public relation articles submitted.

As state chair I had $\frac{39}{100}$ activities with $\frac{3}{100}$ Elks and $\frac{2}{100}$ non-elks with a total of $\frac{104}{100}$ Elk hours and $\frac{3}{100}$ non-elk hours. There were $\frac{3}{100}$ Elk miles and $\frac{3}{100}$ non-elk miles and $\frac{1}{100}$ public relations.

The following is a summary of our Nevada State participation in the 50th Anniversary Hoop Shoot season:

- Eleven lodges participated in a local competition/five did not for various reasons.
- Total of volunteer Elks members during local competition 168
- Total of boys & girls 8-13 participating at local competition 232
- 16 boys/girls 8-13 participated at the Bud Lemmond State Competition
- 6 qualified for Regionals 1-Sparks; 2-Reno; 2-Mesquite; 1-Henderson/Green Valley
- Results at Regionals 1-first 10-11 boy 24/25 Sparks Lodge; 1-second 8-9 boy 23/25 Henderson/Green Valley; 1-third 12-13 boy Reno; 3-4th place 8-9 girl Mesquite; 10-11 girl Mesquite; and 12-13 girl Reno
- Terro Zhang will represent Nevada at Nationals in Chicago April 30, 2022
- All four states at Regionals California-Hawaii, Nevada, Utah & Arizona qualified someone for Nationals

The support of the following individuals and lodges cannot be overstated regarding District and State Competition: Al Babb – Northern District; Nelson Wasserman-Central District and Chuck Coleman-Southern District. Sadly, Earnie Woods – Central District and Chuck Coleman Southern District stepped down during the year. Nelson Wasserman – Hawthorne and James Weis – Henderson-Green Valley took over midstream for the Central and Southern District competitions.

Reno, Hawthorne and Boulder City Lodges hosted the respective District competitions and were a tremendous success. Hawthorne Lodge – Nelson Wasserman conducted their District in Austin, Nevada. Boulder City – Debbie Stolpe conducted the Southern District and Regional Competition. A huge thank you to Hawthorne and Boulder City.

As your State Director, I traveled 2388 miles for District competitions in Austin, Boulder City; State in Hawthorne and Regionals in Boulder City. Countless hours (300) calling 15 lodge directors and Exalted Rulers which in the end qualified one young man for Nationals. My wife and I will represent Nevada and support our 10-11 boys family in Chicago on April 30, 2022.

All the information in the directories comes from CLEMS, so please make sure it is correct before the 1st of May, as this is when we will be sending it out to the printer.

Also, our mailing cost for these directories has become an issue. NSEA Public Relations State Report

April 22, 2022

NSEA President Dan Wells,

Public Relations have improved in Nevada after the disruptions of COVID-19 that closed down a lot of lodges last year. I want to give a special thanks to all my public relations lodge chairs for stepping up, by not only getting their reports into me in a timely manner, but submitting articles to the media. Most lodges had 100% reporting, all year long, with a few not being quite there. Towards the end of this year I have noticed a decline in reporting which puts our State on par with the year before. It is a work in progress and I am addressing that issue with each public relations chair in an attempt to have 100% reporting EVERY month. I have simplified the report to make it easier on the chairs to get their reports into me. All in all, as a group we did a really great job communicating, while having to endure COVID-19 restrictions.

The Elks have held fewer events due to COVID-19 lodge closures, but what few we've had we did a good job promoting and relaying the good deeds we have done for our respective communities. I expect to see media reporting improve now that most lodges are opening up. Also along with this increase in reporting I hope that each lodge, that I had hoped would improve. Hopefully the public relations chairs will improve by next year. The public relations chairs have submitted, since April 1st -2021 until March 31st, 2022, 669 news articles which is up from the year before. Also the Elks have been represented on TV 92 times and 176 times on the radio, both figures being up from the vear before. There have been 3,419 e-mails, lodge website articles and Lodge Facebook posts promoting the Elks, which showed a vast improvement from the year before. Our State Elks also had 13,785 other types of promotions not described in the prior categories. This figure almost doubled from the prior year's figure due to training the public relations chairs what to count. There were numerous situations being overlooked by the chairs due to lack of knowledge. The public relations chair members have volunteered 2,616 hours and drove 7,037 miles to achieve this accomplishment. Both these figures improved dramatically from the year before, proving that the PR chairs have put forth more effort in informing the public what the Elks do.

President Dan and guests,

The Hides Committee at the MidTerm Convention at Reno Lodge distributed a packet to each Exalted Ruler which included: one leather glove, a GL article describing how/where collected hides are processed, information sheet describing how to collect hides as well as preparation, storage and handling.

Throughout the year Lodges were contacted regarding progress or questions.

As of January 2022 only 2 hides were collected statewide. This is primarily because there are fewer hunters, Lodges are not interested in participating in the program as well as perceived storage problems. This is particularly frustrating because Reno Lodge has a shipper who will ship the hides for free — a luxury most Lodges across the country do not have.

The GL Hides Chairman recently informed me that 4 states have decided to no longer participate in the program for the aforementioned reasons. I would recommend Nevada consider this action.
