Nevada Elks Major Project, Inc. (NEMPI) Report - Ken DuBois, Executive

Director/Treasurer -NEMPI informed the members that the NEMPI investment account with Washoe Wealth Advisors-LPL Financial was, as of 10/31/2024, was \$1,269,016.07 and the NEMPI checking account, with US Bank had a balance of \$60,242.20. His attached report highlights the distribution of funds to St. Jude's Ranch and NEMPI expenditures, and copies of bank and investment statements. **He also reported that the Number of Elks Members on the NEMPI Board, 10-expended 40 hours and drove eight hundred miles for their attendance at various meetings.**

We all enjoyed the Friday night State Presidents dinner. State President, Ross Dyer and First Lady Dana, provided a new seating arrangement, with tables named after old ming towns and decorated with a very Nevada Historic mining theme. The seating arrangement allowed members from other Lodges to interact with other Lodge members at their tables. It was a wonderful way to meet members from other Lodges. Wayne Westby, Lodge of the Year Chair, presented the Lodge of the Year Award to Tahoe Douglas Lodge # 2670 for their members' hard work and efforts.

Saturday - The business meeting of the Association was held on November 23, 2024, and called to order by State President Ross Dyer at 8:30 AM. NSEA Sergeant-at-Arms, Jim Mackley, introduced the Honored quests. State President Ross Dyer completed the other introductions.

There was discussion on the disposition of the Charity fund and consideration of the distribution of those funds and the motion was approved by the members.

New Business – There was no pending new business items that were posted on the agenda.

Bills against the NSEA – Sabina Bye, NSEA Treasurer, read the outstanding bills against the Association. Marli Hoesly made a motion to pay the bills against the Association; seconded by Gary Butori. The motion passed unanimously.

Treasurer's Report – Sabina Bye, NSEA Treasurer presented the NSEA Treasurer's Report providing the General Fund checking account balance; the Charity Fund Checking account balance; the NSEA, Inc. Balance Sheet and P&L Report; and the NSEA Charities Fund, Inc. Balance Sheet, and P&L Report.

GL Committeemen Training Sessions – Two training session were put on. One by GL Government Relations, Committeeman, Rick Stone, including information on accurate reporting of volunteer hours and mileage; CLMS update and the importance of getting local government officials to your Lodge functions and activities. The other was put on by GL Fraternal Committeeman, Ronald Brooks. He provided information on Fraternal Pins; Awards for Outstanding Members; Youth Essay Contests and works and guidance available on the Georgia Elks website.

Announcements: NSEA Secretary announced that the 2024-2025 Annual Meeting would be convened on April 24-27, 2025, in Laughlin at Harrah's Casino.

By - laws review and changes were finally approved by the GL Judiciary and the NSEA.

Benediction – Kevin Weis, provided the Closing Benediction.

A motion was made by President Ross Dyer and seconded by Kevin Roukey to adjourn the Business Meeting session at was adjourned.

The State Major Project luncheon: After enjoying a wonderful lunch, Ken DuBois gave an overview of the activities the Board of Trustees have addressed since our Annual Meeting in April. The NEMPI luncheon, ER March raised \$64,562.66, the Raffle Ticket Sales and Silent



Auction raised \$2,355.00 donations from the floor \$600.00 and the Center Piece Auction raised \$1,035.00 for a grand total of \$67,411.66. He also informed the members that the Trustees approved funding \$38,000.00 for upgrading the Healing Centers; and approved (for one-year) the \$45,000.00 salary for a Facility Maintenance Specialist; and approved \$6,200.00 for the purchase of 2000 “Blue Pig” banks. PSP Dee Boskie announced, that although the inclement weather caused the cancellation of the 2nd Annual Mid-Term Golf Tournament, all who entered donated their entry fees to the SMP, in the amount of \$795.00. This brings the SMP funds raised to a **grand total of \$68,206.66.**

President Ross and First Lady Dana thanked all those who helped with them during their visits to each Lodge. The honors given to them were appreciated. President Ross and First Lady Dana made so many new friends during their year that would be impossible to mention. President Ross also gave thanks to the Convention committee chair and the wonderful volunteers that made the meeting such a momentous event. President Ross also expressed her appreciation to the Plaza Hotel and its staff for managing the events and its changes that occurred during the meeting.

The honored guests concluded the session with remarks of thanks and appreciation, and congratulations to the State Association and its members for the achievements expressed during the meetings.

The Nevada State Elks Association Annual Meeting was then adjourned by NSEA President Ross Dyer, stating that the NSEA would reconvene at the Annual Meeting April 24-27, 2025, in Laughlin, NV.
